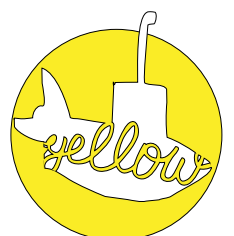


Yellow Submarine exists to support people with learning disabilities, their carers and their families.

the year in review

It's been a busy year. Outputs have grown and behind the scenes we have instigated a number of important safeguarding measures and processes to make the organisation more accountable. We have supported a total of 37 places for people with learning disabilities on residential respite breaks to eight different locations including trips to Dorset, Blackpool and the Isle of Wight. We have provided families and carers with over 4000 hours of important respite time.

personal, careful, safe

On our residential breaks we provide a safe environment giving parents confidence, usually taking a group of five people with disabilities away together. All our holidays are led by trained and experienced staff aided by volunteers, often with close to a 1 to 1 ratio of care. Holidayers can choose from a wide range of destinations and we pride ourselves in providing a natural holiday environment. We don't use sterile care homes for our breaks but make great point of staying in normal, but often breathtaking holiday cottages, usually rented from the National Trust. With the large kitchens, living and dining rooms these properties benefit from we create a sense of shared space, cooperation and mutual support on the holidays.

building confidence

We encourage our holidayers to plan their meals and contribute to shopping, preparing or cooking meals based on their abilities. Everyone is supported on the breaks to learn new skills, express themselves and within a protected environment to look after both themselves and one another. This year we've run two residential breaks which have been specifically designed to increase participants' skills for work and employability, and have included visits to workplaces and volunteer placements.

expanding the service

In addition to our residential breaks and our 'out-and-about' day trips we've continued our monthly gardening club in West Oxfordshire and we've piloted a class looking at self employment skills that we anticipate expanding next year. To assist with our projects we have recruited and trained 16 volunteers who are not only invaluable to our work but who will, we hope, become ambassadors for people with learning disabilities within their own communities as a result of positive experiences with Yellow Submarine.

great feedback

The outcome of our work is significant. Carers have universally told us that they have benefitted from and feel more energized for having a break. Our feedback forms from holidayers record that 82% say they 'gained new skills on the holiday', 79% feel 'less anxious', 82% felt 'more confident', 94% felt 'healthier' and 97% of respondents said they 'made new friends on the holiday'. Perhaps the best testament of all is that over 88% of our holidayers have either come, or are booked to come on another break with us.



give us a break

I'm proud to be the Chair of this young but dynamic charity which was named "Best new voluntary or community group set up in the past two years" at the OCVA awards.

The problems we are seeking to address are significant. People with learning disabilities are increasingly isolated within their communities and afraid to venture out of their homes. High profile cases of bullying and 'mate crime' towards people with disabilities, leading to the murder of individuals such as Gemma Hayter and David Askew have made the front pages of the newspapers this year. Due to cuts in funding, day services and charity projects are closing leaving people with learning disabilities very few places where they feel safe, even to do the basic things in life such as use a bus, go to a shop or meet a friend in a cafe. This in turn is putting greater pressure on family carers who are getting less respite, leading to what a recent Mencap report described as a 'breaking point.'

making a difference

Yellow Submarine is aiming to provide the life skills and confidence to help reduce this 'incarceration at home'. Our residential breaks and training events give individuals the opportunity to take steps towards becoming more independent, to engage with the community and to be able to find work. At the same time we're providing families with valuable respite, allowing parents and siblings to crucially recharge their batteries from their relentless caring tasks to avoid breaking point.

every penny counts

Yellow Submarine is extremely cost efficient which makes the donations and grants we receive go very far. We have minimal administrative costs, running the whole charity with just 2 staff. We rely on volunteers and being financially prudent, wherever possible seeking in-kind donations to minimise our expenses. We are also fortunate to have a committed team- in 2010/11 staff donated 10% of their salary back to Yellow Submarine. Running the charity in an efficient and economic yet effective way is of key importance to the trustees.

our ambition to do more

Pound for pound we punch substantially above our weight - last year we provided over 4000 hours of respite- but we're keen to do more. Demand for respite care is greater than ever and with a small amount of financial support we can help a huge number of families and disadvantaged people where the state is turning its back. This year we have an ambition to extend our help to families with young disabled children and to increase our total support to over 6000 hours of respite. our governance



Charity name - Yellow Submarine Holidays

Administrative details - Yellow Submarine is a company limited by guarantee (number 6619694). The company was registered as a charity with the Charity Commission under Number 1136735 on the 6th July 2010. The registered office is Westhall Barn, Westhall Hill, Fulbrook, OXON, OX18 4BJ

Governing document - The charity is governed by memorandum and articles of association based upon a model Charity Commission document which was adopted on the 18th March 2010. The charity's objects are as follows: "To relieve the needs of and help people with learning difficulties and their carers by providing: (A) supported holidays, support and activities; (B) respite; (C) volunteering opportunities and training for the general public." Trustees - The overall responsibility of the organisation rests with the board of trustees. The selection of Trustees is designed to supplement the existing skills and expertise of the board and is governed by an informal skills assessment. Appointment of trustees is made in accordance with the society's constitution. The following persons served as Trustees during the period under review: Ms Elspeth Lee (Chairperson & director), Mr Roland Allen (Treasurer & director), Ms Kathryn Seward (Secretary & director), Ms Linda Kupczak. There are at least four full Board meetings a year. The trustees appoint a manager, who is responsible for ensuring that their policies and strategies are followed.



Risk assessment - Criminal Records Bureau checks are carried out for all trustees, staff and volunteers. The Trustees have examined the major strategies, business and operational risks which the charity faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to minimise these risks.

Reserves policy - Yellow Submarine does not have a reserves policy. The trustees are actively trying to build reserves via fundraising.



Public benefit statement -Yellow Submarine Holidays provides supported holidays and activities for people with learning disabilities (PWLD). It operates with three aims: 1/ to offer PWLD choice in holiday options and day-trips at affordable prices; 2/ to provide respite for those who care for PWLD; 3/ to give people training and volunteering opportunities. This creates public benefits in health and community cohesion.

**Independent examiner's report to the trustees of Yellow Submarine Holidays.
A company limited by guarantee**

I report on the accounts of the company for the year ended 30 June 2011, which are set out on pages 7 to 11.

Respective responsibilities of trustees and examiner

The trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the accounts. The trustees consider that an audit is not required for this year under section 43(2) of the Charities Act (the 1993 Act) and that an independent examination is needed. The charity's gross income does not exceed £250,000.

Having satisfied myself that the charity is not subject to audit under company law and is eligible for independent examination, it is my responsibility to:

- Examine the accounts under section 43 of the 1993 Act;
- To follow the procedures laid down in the general Directions given by the Charity Commission under section 43(7)(b) of the 1993 Act; and
- To state whether particular matters have come to my attention.

Basis of independent examiner's report

My examination was carried out in accordance with the general directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statement below.

Independent examiner's statement

**Notes to the financial statements
For the year ended 30 June 2011.**

1) Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

a) Basis of accounting.

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and the Statement of Recommended Practice: Accounting and reporting by Charities issued in March 2005.

b) Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Restricted funds are subject to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

c) Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts and is included in full in the Statement of financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes entitled to the grant.

Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included in these accounts.

Investment income is included when receivable.

Income resources from charitable trading activity are accounted for when earned.

Income resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

d) Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include accountancy and legal fees.

All costs are allocated between the expenditure categories of the SoFA on a basis designed to reflect the use of the resources. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis.
